

SAFE WORKING WITHIN NORTHCOTE PRIMARY

- Provide a good example and be a positive role-model by being respectful, fair and considerate to all.
- Treat all children equally – never build a ‘special relationship’ or favour a particular child above all others.
- Ensure that when working with individual children, that the door is left open, or that you can be visible to others.
- Do not photograph children (unless requested by the school staff – use a school camera or iPad only)
- Do not exchange emails, text messages, and phone numbers or give out your own personal details. **DO NOT USE YOUR MOBILE PHONE AROUND PUPILS.**
- Do not receive or give gifts unless arranged through school.
- Only touch children for professional reasons and when this is necessary and appropriate for the child’s well being and safety.

- **Fire Alarm** – Upon hearing the fire alarm, children should be led calmly onto the yard, lined up and registered.
- **Lockdown** – Upon hearing an **intermittent alarm**, children and adults should remain in classrooms, away from doors and windows until further notice. Children should not be made aware of the situation.

DBS certificates

All staff, including supply staff, regular visitors and volunteers are subject to Disclosure and Barring Service (DBS) certificates. This is to help ensure that unsuitable people are prevented from working with children. Advice about DBS certificates is available from Miss Scott in the school office.

SINGLE REGISTER/SCREENING

All visitors are reminded that when they sign in at the Reception Desk they are agreeing to comply with Child Protection Procedures within Northcote Primary School, follow the Code of Conduct and agree to disclose all criminal convictions spent or not. DBS certificates to be presented to Miss Scott and recorded for all visitors having unsupervised access to children.

IDENTITY BADGES

All visitors within Northcote Primary must either wear their visitors badge received from Reception or their agency / school's identity badge. Any adults without a badge will be challenged.

WORRIED ABOUT A CHILD?

Abuse (physical, sexual, emotional) or neglect can have a damaging effect on a child's health, education attainment and emotional well-being. Some changes in a child's behaviour may not necessarily indicate that a child is suffering abuse or neglect. In some cases those changes may be symptoms of a hidden disability, undiagnosed medical condition or changes in medication. If whilst working with a child you become concerned about:

- Comments made by a child
- Marks or bruising on a child
- Changes in a child's behaviour

Please report these concerns to the class teacher or phase leader, who if they feel it is appropriate, will pass the information onto the school's

Designated Safeguarding Lead.

Disclosure of abuse by a child:

Whilst this can be an alarming situation, it is important that you know what to do in such an eventuality and for you to be able to stay calm and controlled.

- Listen to what is being said without displaying shock or disbelief. Accept what is being said.
- Allow the child to talk freely, listen rather than ask direct questions.
- Re-assure the child, but do not make promises that might not be possible to keep.
- Do not promise confidentiality but explain to the child that you have to tell their teacher or Headteacher in order that you can help them.
- Do not interrogate the child or ask leading questions.
- Re-assure the child that it is not their fault.
- Stress that it was right to tell.
- Make them aware that their disclosure will be reported only to those that need to know and can help.
- **Record details of the disclosure immediately, including wherever possible the exact words or phrases used by the child. Sign and date the record.**
- **Report your concerns immediately and give your written record to the Designated Safeguarding Lead / Team to enable the matter to be dealt with in the most appropriate way.**

- Be aware of your own feelings about abuse and find someone you can share your feelings with once the procedures have been completed.

It is important to remember the children's details and names must remain confidential and any discussion that you feel you need to undertake does not allow the child to be identified to anyone else.

ALLEGATIONS

- Any allegations should be reported to the Safeguarding Lead - Mrs. J. Monks or to the Headteacher.
- If the concerns are about the Headteacher please inform the Chair of Governors.

Please follow our Code of Behaviour:

- **Do** treat everyone with respect
- **Do** provide an example you wish others to follow.
- **Do** remember that someone else might misinterpret your actions, no matter how well intentioned.
- **Do** plan activities so that they may involve more than one person or at least are in sight or hearing of others.
- **Do** respect a child's right to personal privacy.
- **Do** act as an appropriate role model.
- **Do** provide access for children and adults to feel comfortable enough to point out attitudes and behaviours they do not like, and try to provide a caring atmosphere.
- **Do not** jump to conclusions without checking facts.
- **Do not** permit abusive activities e.g. bullying, ridiculing.
- **Do not** play physical contact games, make inappropriate comments or have inappropriate banter with the children.
- **Do not** make suggestive remarks, gestures or tell sexist, racist or homophobic jokes.
- **Do not** rely on your good name to protect you. It may not be enough.
- **Do not** believe it could not happen to you. **It could.**
